JOB PURPOSE / OVERVIEW

The Client Health and Safety Data Analyst will be responsible for supporting the development of existing digital tools and platforms used across the HPC project for the enhanced efficiency of data accessibility and interrogation.

Working alongside the Client Health and Safety team the role holder will be responsible for the development of platforms, utilising existing data sources, to automate and manage health and safety data across the project including trend analysis, monthly reporting and ad – hoc requests. The role holder will also have the opportunity to partake in activities and initiatives to resolve poor health, safety and cultural trends identified through their analytical work.

The role is an excellent opportunity to gain knowledge and experience working in the UK new nuclear industry, and an appreciated for identifying, management and resolving health and safety issues across the industry.

CONTEXTUAL INFORMATION

EDF is a core part of the EDF Group, one of the largest energy companies in Europe with key business operations in the UK, France, Italy and Belgium. We're the UK's largest producer of low-carbon electricity, the biggest supplier of electricity by volume in Great Britain, the largest supplier to British businesses, and we employ more than 13,000 people. We operate nuclear, coal and gas power stations, wind farms, and combined heat & power plants. We have a focus on safe, dependable energy generation and an ethos of service excellence. We are playing a leading role in new nuclear build in the UK to secure a bright future for the combined business and its employees.

The HPC Project is the first nuclear new build project for a generation, located on the Somerset coastline adjacent to the Bristol Channel, nestling at the foot of the Quantocks. The project forms the backbone of the UK government's 'Energy Security Strategy'. A plethora of technical and non-technical skills come together on the project, in addition to the convergence of a diverse number of cultures, with the singular commitment being that safety is the project's overriding priority.

As part of the Safety & Regulation directorate, the Client Health & Safety team are responsible for ensuring suitable arrangements for the project including standards, policies and management systems are in place and to provide governance back to the client and board of directors. The Client Health & Safety Data Analyst will provide assurance that arrangements are in line with the EDF Energy Health & Safety standards and specific project requirements, they will work closely with the rest of the Safety & Regulation team who are responsible for applying these standards to the construction project.

PRINCIPAL ACCOUNTABILITIES

- Working with the Client Health and Safety Team and Learning Team to determine the availability of health and safety, and project culture data across the HPC project
- Develop a Power BI dashboard and an associated monthly reporting template for project data, to support the identification, management and resolution of health, safety and project cultural concerns.
- Determine appropriate methodologies to support trend analysis of health and safety data for the project
- Support the Safety & Regulation Director with generation of data and reporting metrics for routine and one-off reporting requirements
- Support development of suitable platforms within the existing HPC digital suite for the enhancement of the visibility of client health and safety deliverables
